After several years of steady implementation, it has promoted the transformation and upgrading of a large number of traditional industries and promoted the strategic adjustment and optimization of China's economic structure.

Through the international circulation as the main mode of China's economic circulation, foreign trade, foreign investment and foreign capital absorption have become the most dynamic fields of China's economy, driving the rapid development of China's economy and the progress of science and technology. This period also laid a solid foundation for proposing to build a new development pattern of double circulation.
