Challenges and Strategies in Building Student Societies in Vocational Colleges

This deficiency hampers effective student participation and satisfaction. Moreover, some societies lack foresight and systematic planning in activity design. Consequently, they fail to incorporate professional features and align with market needs, resulting in poor activity outcomes and difficulty in establishing a brand effect.

3. Strategies

In response to the challenges faced by student societies in vocational colleges, this chapter proposes specific strategies from six aspects: irregular management, funding shortages, low-level and uninnovative activities, weak faculty support, lack of scientific management and effective guidance, and inadequate publicity, aiming to support the healthy development of these societies.

3.1. Optimizing Management Mechanisms and Enhancing Management Efficiency

To address the issue of irregular management, vocational colleges should take the following measures to optimize management mechanisms and enhance management efficiency:

- (1) Simplify the registration and approval process: Schools should simplify the registration and approval process for societies, clarify approval standards and timelines, and improve approval efficiency to ensure societies can be promptly established and active.

- (3) Strengthen member management: In order to foster a dynamic and engaged membership base, we propose to establish comprehensive member archives, refine incentive and exit mechanisms, and bolster member belongingness and participation by organizing regular member meetings and

recognizing outstanding contributions through commendation.

(4) Implement information management: We suggest leveraging campus network platforms or dedicated society management systems for the electronic and standardized management of society information. This approach aims to enhance management efficiency and foster greater transparency, thereby optimizing the overall operational framework.

3.2. Expanding Funding Channels and Ensuring Adequate Funds

To address funding shortages, vocational colleges and societies should work together to expand funding channels and ensure adequate funds:

- (1) Increase school support: Schools should establish special funds to provide necessary financial support for societies and reward societies based on their activity performance.
- (2) Diversify funding sources: Societies are encouraged to diversify their fundraising strategies by leveraging school-enterprise collaborations, securing social sponsorships, submitting project applications, and exploring other innovative avenues. Societies can also consider organizing profitable activities, such as skill training and consulting services, to increase income.
- (3) Establish a funding supervision mechanism: Strengthen supervision of society funds to ensure legal and reasonable use. It is imperative to regularly conduct audits of the financial status and subsequently disclose the findings to maintain transparency in the utilization of funds.

3.3. Enhancing Activity Quality and Stimulating Innovation

To address low-level and uninnovative activities, vocational colleges and societies should take the following measures to enhance activity quality and stimulate innovation:

- (1) Integrate professional features: Societies are encouraged to organize activities that seamlessly integrate professional features, such as skill competitions and project-based practices. These endeavors not only refine the professional skills of members but also enhance the overall attractiveness and relevance of the society's activities.
- (2) Introduce industry resources: It is advisable to invite industry experts and corporate mentors to offer guidance and collaborate in planning society activities. Their expertise and insights provide invaluable cutting-edge industry information and professional guidance, thereby elevating the professionalism and practical relevance of the society's endeavors.
- (3) Encourage innovative thinking: To ignite students' creativity and foster a culture of innovation, it is essential to organize creative competitions and innovation workshops. Furthermore, recognizing and rewarding innovative activities serves as a catalyst, nurturing a positive environment where creativity and novelty are celebrated and encouraged.

3.4. Strengthening Faculty Development and Enhancing Guidance Capability

To address weak faculty support, vocational colleges should take the following measures to strengthen faculty development and enhance guidance capability:

- (1) Attract professional talent: Efforts should be intensified to attract professional guidance teachers, particularly those with industry backgrounds and extensive practical experience. Additionally, providing these individuals with necessary training and development opportunities is crucial to enhancing their professional competence and guidance abilities, thereby benefiting the students under their tutelage.
- (2) Establish a mentor system: Implementing a one-on-one or one-to-many mentor system, whereby societies are assigned fixed guidance teachers, can foster deeper relationships and ensure tailored support. Guidance teachers should regularly communicate with society members, monitor

development dynamics, and provide targeted advice and support.

(3) Strengthen school-enterprise cooperation: Collaborating closely with enterprises and inviting corporate experts as part-time mentors or advisors for societies strengthens the connection between academia and industry. This school-enterprise cooperation fosters resource sharing and complementarity, fostering a mutually beneficial environment that jointly propels society development.

3.5. Reinforcing Scientific Management and Effective Guidance

To address the lack of scientific management and effective guidance, vocational colleges and societies should take the following measures to reinforce scientific management and effective guidance:

- (1) Develop development plans: Societies should develop clear development plans and goals, defining their positioning and direction. Schools should review and guide these plans to ensure alignment with overall development goals.
- (2) Strengthen brand building: It is recommended to encourage societies to prioritize brand building endeavors by showcasing their high-quality activities and notable achievements, thereby augmenting their visibility and reputation within the relevant domains. Schools should provide necessary brand building and promotion support.
- (3) Introduce evaluation mechanisms: It is imperative to establish rigorous scientific evaluation mechanisms for societies, which involve regular performance assessments and subsequent feedback provision, to ensure continuous improvement and accountability. Evaluation results should serve as important bases for funding support and teacher evaluations.
- (4) Provide professional training: Professional training opportunities should be provided for school managers and society advisors, aimed at elevating their management capabilities and guidance standards, thereby fostering a more effective and supportive environment for societies. Training content can include society management theories, activity planning and execution techniques, and industry trends.

3.6. Increasing Publicity Efforts and Expanding Influence

To address inadequate publicity, vocational colleges and societies should take the following measures to increase publicity efforts and expand influence:

- (1) Utilize new media platforms: It is essential to fully harness campus network platforms, including WeChat public accounts, Weibo, and other emerging media channels, for promotional purposes. By publishing society news, activity announcements, and notable achievements, we can effectively capture the attention of students and encourage their participation, thereby fostering a vibrant and engaged community.
- (2) Organize promotional events: Large-scale promotional events, such as society culture festivals and recruitment fairs, should be organized to showcase the distinctive features and styles of various societies. These events should incorporate interactive and experiential activities to bolster their promotional effectiveness, ultimately attracting a wider audience and fostering a deeper appreciation for the diversity of societies.
- (3) Strengthen internal and external cooperation: Collaborations with both internal and external media outlets should be forged to ensure comprehensive coverage and promotion of society activities. Furthermore, active participation in both internal and external events and competitions presents an invaluable opportunity to showcase society achievements and unique styles, thereby enhancing their reputation and visibility.
 - (4) Foster collaboration with other organizations: The publicity team should actively collaborate

with other societies, student unions, and youth leagues to jointly plan and execute promotional activities. By leveraging resource sharing and complementary advantages, we can significantly expand the coverage and influence of our publicity efforts.

In summary, this paper proposes specific strategies to address the challenges faced by student societies in vocational colleges, aiming to promote their healthy development through optimizing management mechanisms, expanding funding channels, enhancing activity quality, strengthening faculty development, reinforcing scientific management and effective guidance, and increasing publicity efforts. These measures aim to provide diverse extracurricular activities and growth platforms for students.

4. Conclusion
