3.3. Case education is integrated into course ideological and political education to teach students to put the interests of the public at the forefront

In the ideological and political course of finance and accounting major, teachers should analyze professional problems through a variety of cases, discuss the social responsibility of enterprises, and make students realize the possible conflicts between personal interests, corporate interests and social public interests. Through in-depth study of cases, the teaching is more interesting, while enriching the form of teaching ideology and politics, making the teaching content more specific and vivid.^[14]

4.1. Further develop ideological and political elements to help students establish a correct outlook on life
