Research on the Sports Events Differences of Ideological and Political Education in the Integration Course of College Physical Education

In education, he advocated "abolishing stereotyped writing and developing western learning", and put forward a comprehensive educational view of "moral education, physical education and intellectual education" . Kang Youwei in the book of Datong, on the basis of the physical and mental characteristics of children, referred to the requirements of physical development at all ages. For college Students of Physical Education, the book said, "should also attach importance to gymnastics learning, to Run the blood, strengthen the bones ". The whole reformists began to advocate the propaganda of physical education from the all-round development of morality, intelligence and body, these advanced thoughts laid a theoretical foundation for the implementation of school physical education in later period of our country. Subsequently, the Great Leader Mao Zedong in his book "Sports Research" profoundly expounded the importance of physical exercise, "the body is the capital of the revolution" this great idea, can be seen from ancient times, on the importance of physical exercise, human beings have a unified understanding. Today, general Secretary Xi Jinping stressed at the National Conference on Ideological and political work in colleges and universities that, "The course of ideological and political theory should be strengthened in the course of improvement, and other courses should stick to a good channel and cultivate a good field of responsibility, so that all kinds of courses and ideological and political theory courses go together and form a synergistic effect.
