### **3.4 Personality Reform to Address Existing Problems**

Although a large number of counselors can follow the unified management system established by the school, due to some subjective or objective factors, some counselors still have personal demands, and colleges and universities need to establish a personalized action system based on this content and principle to solve the problems between counselors and students. For example, although a counselor can actively perform his / her personal duties in the actual work education process, it infringes on the interests of some students, On the other hand, in the case of the current report, the school believes that the counselor does have a certain degree of problem handling irregularities, and in order to improve the handling level of various problems, it can also build a complaint channel for counselor application. After the comparison and analysis of materials from both sides, the school studies the current counselor's work level according to the actual situation..

### **4.1 Rethinking of Work Quality**
