1.2. Adapt to the needs of family structure changes

According to a survey conducted by the Institute of Sociology of the Chinese Academy of Social Sciences on five urban families, including Beijing, Tianjin, Nanjing, Chengdu, and Shanghai, the proportions of nuclear families, immediate families, and joint families in the five cities were: 67.75%, 19.28% and 2.420.6, the proportion of single- or second-child families in nuclear families is significantly higher, accounting for 77.7% of the total number of urban nuclear families. It is predicted that at the end of this century, "Four two two" family types will become the main type of family in our cities, ^[2]which shows that with the changes in family structure and the fast pace of modern life, many "dual workers" have no time to take care of elderly or sick elders, so families Middle-aged care for the elderly becomes a heavy burden on young people. Therefore, the development of community service centers, the establishment of apartments for the elderly, and the implementation of apartment-based pensions for the elderly are the guarantee for the elderly to live a good life in the old age, as well as a major social task to address the worries of each family.

1.3. Adapt to the needs of the elderly's own development

The establishment of "elderly apartments" can effectively solve the five "existing" problems of urban elderly, especially retired elderly. The apartment for the elderly can provide the elderly with support, medical care, and pleasure, reduce the mental burden on children, and provide an objective environment for remarriage. Coupled with the changes in people's ideology, in the past the elderly had the idea of "raising children and preventing the elderly"; while children were sent to the elderly homes, they were afraid of being described as "unfilial." 1.4. Needs to improve the old-age security system

3. Innovation of new models for combining nursing care with nursing homes

Third, "love" is the basis of medicine, that is, medical care for the elderly should be full of love and warm care, the purpose is to make the elderly live a more dignified and more happy. Under the traditional Chinese culture and human needs, the elderly have a strong desire for the home. The home is provided with hardware and environment for the home. "Closing the door is a small home and opening the door is everyone." There is a home in the institution. " It not only meets the habit of traditional family companions, but also meets the modern concept of self-pursuit. The senior apartments mainly support hospitals and nursing homes, and develop professional medical and nursing teams such as physicians, pharmacists, rehabilitation physiotherapists, nurses, nurses, and nursing staff. The "care" and "medicine" of the elderly are completed within the affinity source, which not only avoids the spatial separation of traditional medical care services from bringing inconvenience and emotional separation to the elderly and the family, but also "liberates the wife and the children.

3.2. Construction innovation

The comprehensive elderly residential area is designed and constructed according to the physiological and psychological characteristics and needs of the elderly. It is designed and built according to the physical and psychological characteristics and needs of the elderly, guided by the barrier-free and humanized design concept, providing self-care conditions, housing equipment for the elderly, and integrating and supporting the entire family, optimization.

3.3. Scientific and technological innovation

At the early stage of the construction of senior apartments, it was determined to allow the senior citizens to fully enjoy the achievements of science and technology and social progress, and advocated "technology to help the elderly and smart pension". [8] The apartment integrates the most advanced software and hardware facilities at home and abroad, and combines its own functional positioning and service goals to design personal consumption, regional positioning, access control security, mobile alarm, and indoor emergency calling as service management ERP systems to build a "smart retirement" life model. [9] The application of "mobile, cloud, big data, and Internet of Things" technology to promote service improvement, build a platform for the interaction between the elderly and their children, and realize the real technology to help the elderly.

3.4. Continuing Innovation in the Value of the Elderly

Establish a mutual aid system for the elderly and a community support system for the elderly. Through the creation of a "time bank" model, the development of elderly volunteer organizations, the role of "supported" to "self-help pension" in mutual assistance, and self-help in the process of mutual assistance. Through the public welfare classroom, practice the spirit of "the public welfare achieves the value of the elderly", [10] promote the elders' style of doing something good, and develop the orientation of affinity Social youth education activities, Sudoku, fun painting, recitation, table tennis, harmonica and other projects have become the featured projects of summer public welfare classrooms, and have received widespread attention from the society.
